**March 19, 2009**

1. **Call to order:** Chair Brodersen called the Meeting to order at 7:03 p.m.
  - a. Commissioners Present: John Kiely, Jim Lucas Dan Budsberg and Paul Donohue and Chair Bret Brodersen. Staff Present: Senior Planner Pete Swensson, Admin Clerk Joy Katyryniuk.  
Guests: City of Tenino Council member John O’Callahan.
  - b. Chairman Donohue led the Flag salute.
  - c. Agenda Approval: **Commissioner Donohue moved** to approve the agenda as presented; the motion was seconded by **Commissioner Kiely**. The motion carried 4-0.
  - d. Approval of Minutes: **Commissioner Budsberg moved and Commissioner Donohue seconded** to approve the minutes of the February 19, 2009 regular meeting minutes. Motion carried 4-0. **Commissioner Budsberg moved and Commissioner Lucas seconded** to approve the March 12, 2009 meeting minutes. Motion carried 4-0.

  - c. Emergency Response Plan – Commission discussed possible emergency situations when the citizens of Tenino could help city staff. Commission also discussed liability issues that may arise, Chair Brodersen advised
  - d. Traffic Plan- Commission discussed past one way street ideas, the possibility of reopening Wherrett Street and adding speed bumps, a possible by-pass road for trucks around the city. Commissioners will discuss one way streets and parking in future meetings.
  - e. History Document – Chair Brodersen asked if Commissioner Budsberg needed any additional information. Commissioner Budsberg would like to see the 11x17 color document of the one way streets in Tenino which he thought was made prior to August 2006. Chair Brodersen advised he would see if he could locate it.
4. **New Business:**
  - a. Chairs Report – Chair Brodersen advised he spoke with the Mayor regarding when there would be details in regards to the Parks Commission. The Mayor advised

that it is so new that they are going to need time to make decisions on the details.
