Please return your completed entry forms and indemnity agreement before July 1, 2006. Entries received after July 1st will be accepted as parade participants but will not receive top priority in placement in the parade. Early entries are encouraged.

Entry forms should be neatly printed so they are easy to read. If an entry form or indemnity agreement is not filled out completely your entry will not be accepted. Be sure to sign the indemnity agreement. Your entry description should include enough information to enable us to determine an appropriate spot in the parade lineup for your entry. While we welcome holders of and candidates for political office, they must limit the number of vehicles in their entry to two. We will be pleased to furnish any further information you may need.
